OFFICIAL MINUTES OF THE JUNE 23, 2015 SPECIAL MEETING
OF THE CITY COUNCIL

Present were Mayor Jack Conatser, Council Member Rose Crawford, Council Member Jill Owen and Council Member Dan Lannen. Council Member Stewart Merja was excused.

There was no staff present.

Citizens present were Sally Haas of the Soroptimists, Lindy Troy of Moms of the Park and Jeff Erickson of The Party Place/Kids Fun Zone.

CALL TO ORDER

Mayor Conatser called the special meeting to order at 6:00 p.m.

DISCUSSION AND VOTE ON ALLOWING THE PARTY PLACE/KIDS FUN ZONE TO
SET UP A CARNIVAL JULY 3rd - JULY 5TH IN THE CITY PARK

Lindy Troy introduced Jeff Erickson of The Party Place/Kids Fun Zone. Mr. Erickson explained that he would bring some bounce houses, a kiddie swing and ferris wheel and other kiddie rides. He is also looking at bringing spray on tattoos and games. He stated that part of the revenues will be donated to the Moms of the Park playground fundraiser. They discussed possible areas to put it and decided that the carnival will be placed near the white bathroom. Mayor Conatser asked if he had proof of insurance. Mr. Erickson stated that he would bring in a copy with the city named as an additional insured. Council Member Owen asked if he would be in conflict with the musical entertainment. He replied that it will not be loud enough to be a problem. Council Member Owen asked if there would be a charge for the rides. Mr. Erickson replied that the kids will be able to buy one ride or a half or whole day pass. Mr. Erickson asked what the charge for a vendor space would be. Ms. Haas replied that it is \$25 for a space. Mr. Erickson stated that he would pay for two spaces to help the Soroptimists as they will be bringing in a large crowd.

Council Member Lannen made a motion to allow The Party Place/Kids Fun Zone to set up a carnival in the park July 3rd - 5th, seconded by Council Member Crawford. The motion passed with all in attendance voting aye.
