NEW BUSINESS

VOTE ON PAY REQUEST NO. 3 – PROSPECT CONSTRUCTION

The new water project for Waterline Replacement is in full swing, weather permitting. We received pay request #3 for \$221,263.55 which will break out as \$219,050.91 for the contractor Prospect Construction and \$2,212.64 in MT Gross Receipts Tax. A motion to pay the request was made by Council Member Dogiakos, seconded by Council Member Coccoli. The motion passed with all in attendance voting aye.

VOTE ON PROPERTY CONVENANT – COUNTRY CLUB ADDITION – 13^{TH} AVE NE

It was requested by the current residents that reside in the Country Club Addition along the east side of 13th Ave NE that the City prohibit uses of the City Right-of-Way designated as 14th Ave NE, which is currently undeveloped. The owners, current and future, shall deem the usage of the right-of-way known as 14th Ave NE as open space similar to that of a park for all uses. The residents owning the properties have signed the covenant. A motion to approve the covenant was made by Council Member Merja, seconded by Council Member Coccoli. The motion passed with all in attendance voting aye.

CLAIMS

A motion to approve a second set of claims for April 2023, check #21823 – 21844, with a total of \$282,370.26 was made by Council Member Dogiakos, seconded by Council Member Coccoli. The motion passed with all in attendance voting aye.
