# OFFICIAL MINUTES OF THE AUGUST 1, 2023 MEETING OF THE CITY COUNCIL

#### CALL TO ORDER

Mayor Hindoien called the meeting to order at 5:30 p.m.

#### APPROVAL OF THE MINUTES

A motion to approve the minutes of the July 18, 2023, meeting was made by Council Member Dogiakos, seconded by Council Member Coccoli. The motion passed with all in attendance voting aye.

#### **NEW BUSINESS**

#### VOTE ON DEPUTY CLERK POSITION

Deputy Clerk Frownfelder explained that after reviewing and updating the job description, the position would be posted internally for 5 days. The position is being offered at \$19-\$21 an hour based on experience. If the position is not filled internally then it will be advertised to the general public. Council Member Coccoli asked if there would be a hiring committee. Mayor Hindoien explained that there would be an Interview Committee consisting of himself, all department heads and two council members.

Council Member Dogiakos made a motion to accept the recommendation to start the hiring process. Council Member Merja seconded the motion. The Motion passed with all those in attendance voting aye.
