VOTE ON PAY REQUEST #7 – PROSPECT CONSTRUCTION

We received pay request #7 for the water project for Waterline Replacement. The request is for \$803,564.59 which will break out as \$795,528.94 for the contractor Prospect Construction and \$8,035.65 in MT Gross Receipts Tax. Council Member Dogiakos made a motion to pay Prospect Construction. Council Member Coccoli seconded the motion. The motion passed with all those in attendance voting aye.

VOTE ON RECORDS DESTRUCTION REQUEST, DEPUTY CLERK

Council Member Dogiakos made a motion to approve the destruction of the records. Council Member Merja seconded the motion. The motion passed with all those in attendance voting aye.

APPOINT NEW ZONING BOARD MEMBERS

Council Member Coccoli made a motion to approve the reappointment of Al Kostelnik for a new term of 3 years (ending December 2025) and to accept the appointment of Steve Dogiakos in replacement of Jim Bouma as of 01/01/2024. Council Member Merja seconded the motion. The motion passed with all those in attendance voting aye.
